2) Our staff is feeling insecure about asking transgender/gender non-conforming and sexual orientation questions now required by the State. Any advice about how to ask questions?

3) Can you talk about programming and/or initiatives that SAGE is prioritizing for LGBTQ+ older adults in the coming 1-2 years so that AAAs with upcoming Area Plan cycles can effectively incorporate these priorities?

Concerns SAGE often prioritizes include Caregiving Support, Social Isolation, Financial Health and Wellbeing, Transportation, Food Security, and Affordable Housing, to name a few. SAGE also stresses the importance of reaching out LGBTQ+ communities of color, rural communities and people aging with HIV. It is important for AAAs and SUAs to include demographic questions inclusive of sexual orientation and gender identity so your state and local communities can learn about the unique needs of LGBTQ+ older adults in your communities.

4) Are there strategies for reaching LGBTQ+ people in rural areas?

Rural areas often lack LGBTQ+ specific programs making LGBTQ+ inclusion even more critical. The best practice guide, *Inclusive Services for LGBT Older Adults: A Practical Guide to Creating Welcoming Agencies* (https://lgbtagingcenter.org/resources/resource.cfm?r=487) provides an opportunity for rural serving organizations to consider steps to becoming more welcoming and inclusive.

Rural aging services may also want to connect with LGBTQ+ Community Based Organizations and LGBTQ+ Affirming Faith Based Communities in suburban and urban areas. 5) What is the thought around how to include sexual orientation or gender identity on a Risk Assessment?

It is recommended that **any time** demographic data is collected on assessments and intake forms, that sexual orientation and gender identity (SOGI) questions are included. As with any demographic data, these questions should remain optional for the respondent to answer. The Behavioral Health Risk Factor Surveillance System is an example of where some states have opted in to include the SOGI module.

6) I'm looking for resources on the intersection of aging and disability - we've had trouble explaining pronouns to many of our older clients with mental health concerns.

This fact sheet is a starting point and can modified to fit the needs of your organization.

10) Are there any programs/priorities/services for older LGBT coming back into the workforce from retirement?

Workforce re-entry and employment for LGBTQ+ older adults is an important focus. Senior Community Service Employment Programs (SCSEP) funded through the Department of Labor serve as one the key entry points for older adults seeking employment assistance. SAGE recommends that SCSEP programs provide outreach to LGBTQ+ older adults and ensure LGBTQ+ cultural competency training is available to employees and volunteers running SCSEP programs.

14) How can the AAA be inclusive from an intersectionality perspective (e.g., people with hearing loss, vision loss, Limited English Proficiency)?

SAGE encourages AAAs to consider intersectionality when reaching out to LGBTQ+ communities. At the local level you may find organizations who support people living with disabilities or cultural

groups that also have LGBTQ+ initiatives. These community organizations can be key in connecting with diverse LGBTQ+ older adults and family caregivers.

15) What resources are available to support people Transgender older adults and their families?

From our research, demographic questions include a question on sex and sexual orientation. SAGE recommends a question on gender identity be added.
